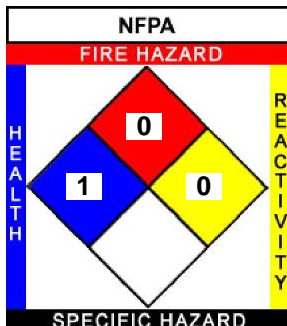

FIRST AID MEASURES

HANDLING AND STORAGE
